BY-LAW NUMBER 69-2013

**BEING A BY-LAW TO AMEND BY-LAW NUMBER 45-2012 BEING A BYLAW TO
MAINTAIN, MANAGE, REGULATE AND CONTROL THE SHELBURNE CEMETERY
AND REGULATE PRICE LISTS**

WHEREAS the Council of The Corporation of the Town of Shelburne deems it expedient to amend By-law Number 45-2012;

AND WHEREAS the attached Schedule A of By-law Number 69-2013 amends the fees and charges for the Corporation of the Town of Shelburne's Cemetery;

NOW THEREFORE the Council of The Corporation of the Town of Shelburne enacts the following:

1. That the attached Schedule A amends the fees and charges for the Corporation of the Town of Shelburne Cemetery which forms part of this By-Law No.69 -2013 and that Schedule A of By-law Number 45-2012 Cemetery Price List be rescinded upon passing of this by-law.

CARE and MAINTENANCE FUND

The deposit to the care and maintenance fund payable when a marker is installed in the cemetery shall be as specified in the regulations made under the Cemeteries Act:

- i) Installing a flat marker measuring less than 173 square inches (1116.3 square centimetres)
\$0.00
- ii) Installing a flat marker measuring at least 173 square inches (1116.3 square centimetres)
\$50.00
- iii) Installing an upright marker measuring four feet (1.22 metres) or less in height and four feet or less in length (1.22 metres) including the base \$100.00
- iv) Installing an upright marker measuring more than four feet (1.22 metres) in either height or length including the base \$200.00
